

Open call for part time expertise

The Foundation, inspired by Anna Lindh's legacy, is committed to fostering intercultural dialogue within its mission of nurturing inclusive societies where diversity is celebrated and everyone's voice is valued. By promoting peace, justice, and strong partnerships, the Foundation strives to create a world where people from diverse backgrounds live in harmony through open and meaningful intercultural exchanges.

ALF brings together organisations, institutions, policy makers, and other change makers from all Euro-Med countries to open a dialogue and cooperate. People meet, learn, and collaborate, through the Foundation's different projects and initiatives in different fields to empower them to create a chain of positive change that touches more lives and communities. Its action grounds on the two main bodies of the Foundation: It's Civil National Networks with more than 4,500 members and the 42 Members States of its Board of Governors.

Eligibility

Offers must come from nationals of one of the 43 (UfM) countries:

Job location and dedication

Work from remote with a possibility to have physical meeting at the ALF Secretariat as required. The dedication foreseen is part time 50%

Maximum financial allocation

The maximum financial envelope available for this call is 160.000 euro for a dedication of 50% and a duration of 32 months.

Contract typology

Local contract or International service contract depending on the nationality of the selected candidate. Local contracts are subject to monthly deductions according to the regulations of the Egyptian Income Tax Authority and Egyptian Social Insurance Authority. International service contracts are free of Egyptian taxation, but they are not exempt from the abroad local income tax, if any.

Starting date

The estimated start of the contract is foreseen for 1 May 2024, terminating on 31 December 2026.





Contract framework

The contract will be formalised in the framework of "Mediterranean Youth in Action, MYA" Grant Agreement.

Vision of the Programme

The Mediterranean Youth in Action (MYA) program strives to encourage political participation among young people, bridge the gap between generations, and promote active citizenship in the Mediterranean region. The programme aims to engage committed young people through various activities and empower them as agents of positive change and responsible leaders.

Key responsibilities

- · Analyse the Euro-Mediterranean and National policy frameworks related to youth, gender and intercultural dialogue and provide guidance to embed them into the MYA and ALF actions
- · Advise the ALF Executive Director and the MYA Programme Leader on new formulas to foster civil society cooperation and engage civil society entities, as a key factor of cohesion, in line with the MYA's objectives
- · Conceptualise and strategise MYA activities in line with the ALF mandate, in a way that maximises their policy relevance and their impact on policy making, particularly on transforming inputs into actionable ideas and policy recommendations
- Liaise national and regional institutions and map events/initiatives opportunities at the Euro-Mediterranean scale to set a MYA agenda consistently with the evidence-based research activities and its institutional objectives
- · Contribute to guarantee compliance with the targets, outputs and outcomes defined in the MYA formulation in terms of institutional relations, Intercultural Stakeholders' Dialogues and evident-based research, including the elaboration of the related narrative and financial reports and other formal documentation
- · Carry out field missions related to specific meetings, events or field assessments and report about them
- · Perform any other function related to the position of MYA Institutional & research external expert requested by the Executive Director or the MYA Programme Leader
