Who can apply

Young researchers of age between 18 and 35, from the 43 countries of the UFM, who are proficient in English, and affiliated to a think tank, a specialized research centre or a university.

How to apply

Initiate your involvement by submitting your online application via the available online form only (hyperlink) before 27 June 2024 23.59 Central European Time, CET. Ensure alignment with the criteria, demonstrating your commitment to driving positive change in the Euro-Mediterranean region.

Only complete applications, meeting the criteria and submitted before the deadline will be considered.





Please note that it is not possible to save the application as a draft or to make any changes after submitting it. At the close of the call, the most recently submitted version of the application will be processed. The same applicant cannot submit more than one proposal under this call.

Due to the high volume of expected applications, responses to individual requests will not be provided. Only pre-screened candidates will be contacted.

Programme phasing

Understanding the steps of the application process is crucial for a seamless and successful journey with "Voicing Youth Knowledge" component of the Mediterranean Youth in Action Programme. Here is a breakdown of the process:

· Application submission

You will kickstart your journey with MYA by applying by the specified deadline, ensuring you meet the eligibility criteria, and showcasing your dedication to contributing to the Euro-Mediterranean vision. This includes the submission of a short abstract of up to **500 words** demonstrating originality and incorporating diverse disciplinary and methodological approaches.

- Online skills enhancing training (for 50 pre-selected young researchers)
 If pre-selected, you will participate in an online training programme. This training will enhance your research and communication skills, preparing you for the challenges ahead. All young researchers taking the training successfully will receive a certificate of completion from the ALF Secretariat.
- Extended policy-oriented research proposal (for 50 pre-selected young researchers)

 Following the online training, you will be required to create an extended policy-oriented research proposal of 1,000 words. This proposal will showcase your innovative solutions and demonstrate your ability to address Euro-Mediterranean issues. Based on the quality of the extended proposals, 25 researchers will be chosen to participate in a face-to-face Knowledge Workout Workshop.
- · Face-to-face knowledge Workout Workshop (for 25 selected researchers)

This workshop (1.5 days) will offer a platform for you to present your extended policy-oriented research outlines to an audience of peers and selected stakeholders, receiving valuable feedback to refine your work. Moreover, this gathering presents a unique opportunity to foster a sense of community and collaboration on the Euro-Mediterranean scale, enhancing connectivity and synergy among young researchers from diverse backgrounds

• Elaboration of policy briefs (for up to 15 final selected researchers)

From the 25 participants in the Knowledge Workout Workshop, up to 15 young researchers will be selected to receive financial support for crafting a 3,500-word policy brief, a blog post (500 words), and other communication products in English. The final selection is contingent upon passing a peer review process.

· Publication and dissemination

Upon successful completion and validation, the policy briefs will be translated into French and Arabic for broad dissemination. The selected works will be published on the ALF Website and added to the





ALF Intercultural Dialogue Research Centre. The ALF Secretariat will actively disseminate the policy briefs at the Euro-Mediterranean scale.

Face-to-face evaluation and results sharing meeting (MYA Forum)

The 25 beneficiaries in the Knowledge Workout Workshop will be invited to participate in the MYA Forum that brings together youth, decision-makers, and stakeholders from the Euro-Mediterranean region at the end of the cycle. It provides a platform for sharing insights, fostering collaboration, and addressing key issues related to youth empowerment and intercultural dialogue. It will be also the occasion to evaluate the impact of the "Voicing Youth Knowledge" component to improve further editions. The MYA Forum will take place back-to-back to the ALForum, scheduled to take place in the first quarter of 2025.

Benefits of participation

Online training with certification (for 50 young researchers)

Acquire advanced skills through an online training programme led by experts. Upon completion, receive a certification from the Anna Lindh Foundation (ALF) Secretariat.

- Face-to-face Knowledge Workout Workshop (for 25 selected researchers)
 - Immerse yourself in an engaging face-to-face workshop, gaining valuable insights and feedback that will refine your research approach and methodologies.
- · Financial support for policy brief publication (for selected researchers)

Excel to be among the 15 selected researchers who will be tasked with crafting a 3,500-word policy brief, a blog post (500 words), and other impactful communication products; the successful researchers will receive a financial contribution of 1.000 euro.

· Increase the visibility of your evidence-based research

Make your evidence-based research accessible to various stakeholders and practitioners. Leveraging the ALF communication tools and network will enhance the dissemination of your research.

- Civil Society Outreach Dialogues (for selected researchers)
 - Participate in Civil Society Outreach Dialogues to be organised nationally. Join these 2-hour sessions accompanied by local stakeholders and civil society representatives. Engage the public, making your research visible and impactful in communities.
- Financial support for academic dialogues (for selected researchers)

Receive financial support to organize an Academic Dialogue (1.5 hours) in your institution. These dialogues may take various forms, from specialized seminars for the academic/research community to interactive events for student engagement. This initiative aims to empower young researchers and enhance their visibility within their work contexts.

· Networking opportunities

Build valuable connections within your field and beyond. Engage with fellow researchers, stakeholders, and civil society representatives, creating a robust network for potential collaborations and future endeavours.





Communication contribution

Actively contribute to communication initiatives, you will get the chance to share your testimonies about your experience with the MYA Programme and your research.

The top-performing young researchers will have the opportunity to actively participate in dynamic events and dialogues organised at the Euro-Mediterranean scale, amplifying youth voices and perspectives, fostering dialogue, and connecting with stakeholders and peers across the region.

Selection Criteria

The selection process for "Voicing Youth Knowledge" under the Mediterranean Youth in Action (MYA) Programme is designed to ensure fairness, diversity, and relevance. Special attention will be given to gender and geographical balances to ensure a diverse and inclusive representation.

The following criteria will be taken into account to select passionate and dedicated young researchers who will contribute meaningfully to the Euro-Mediterranean vision:

1. Euro-Mediterranean scope of the research proposal (35%)

Potential impact of the research proposal on Euro-Mediterranean public policies





2. Relevance of the research proposal (30%)

Evaluation of the alignment between the proposed research and the proposed research topic

- 3. Added value and originality (20%)
 - Originality and added value of the research approach taken by the applicant
- 4. Academic and professional background (15%)
 - Applicant's academic and professional history

The proposed research work should be original and unpublished. The ALF retains co-ownership of the publishing rights and intellectual property for the final knowledge product.

Background

The Anna Lindh Euro-Mediterranean Foundation for the Dialogue between Cultures, ALF, (https://www.annalindhfoundation.org), created in 2005 as an international intergovernmental organisation based in Alexandria. The Foundation, inspired by Anna Lindh's legacy, is committed to fostering intercultural dialogue within its mission of nurturing inclusive societies where diversity is celebrated, and everyone's voice is valued. By promoting peace, justice, and strong partnerships, the Foundation strives to create a world where people from diverse backgrounds live in harmony through open and meaningful intercultural exchanges.

ALF brings together organisations, institutions, policy makers, and other change makers from all Euro-Med countries to open a dialogue and cooperate. People meet, learn, and collaborate, through the Foundation's different projects and initiatives in different fields to empower them to create a chain of positive change that touches more lives and communities. Its action grounds on the two main bodies of the Foundation: It's Civil National Networks with more than 4,500 members and the 42 Members States of its Board of Governors.
